FINAL AUTHORITY: Naabik'íyáti' Committee



15 BE IT ENACTED:

16 **Section One. Authority**

- 17 A. The Naabik'iyáti' Committee of the Navajo Nation Council is a standing committee
18 of the Navajo Nation Council. 2 N.N.C. § 700 (A).
19 B. The Naabik'iyáti' Committee of the Navajo Nation Council exercises legislative
20 oversight for the Diné Uranium Remediation Advisory Commission with the
21 authority to approve the Diné Uranium Remediation Advisory Commission's Plan of
22 Operation and Rules of Order. 2 N.N.C. § 3582, CAP-14-15, NABIAU-52-15.

25 **Section Two. Findings**

- 26 A. In 2015 the Navajo Nation Council established the Diné Uranium Remediation
27 Advisory Commission. 2 N.N.C. § 3580, CAP-14-15.
28 B. The Naabik'iyáti' Committee amended the Plan of Operation for the Diné Uranium
29 Remediation Advisory Commission (NABIAU-52-15) with resolution CJA-14-17
30 which is attached as **Exhibit C** (with Exhibit 1).

1 C. This legislation proposes amendments to the Plan of Operation to change the number
2 and qualifications of Commission members, in addition to other amendments.

3 D. The proposed amended Diné Uranium Remediation Advisory Commission's Plan of
4 Operation is attached as **Exhibit A**.

5 E. The Diné Uranium Remediation Advisory Commission's Plan of Operation at Section
6 XIV (Meetings and Procedures) states that the Rules are to be approved by the
7 Naabik'iyáti' Committee. The proposed Diné Uranium Remediation Advisory
8 Commission Rules of Order are attached as **Exhibit B**.

11 **Section Three. Approval of Amendments to the Diné Uranium Remediation
12 Advisory Commission Plan of Operation**

13 The Naabik'iyáti' Committee of the Navajo Nation Council hereby approves the
14 Amended Plan of Operation for the Diné Uranium Remediation Advisory
15 Commission, attached hereto as **Exhibit A**.

17 **Section Four. Approval of the Diné Uranium Remediation Advisory Commission
18 Rules of Order**

19 The Naabik'iyáti' Committee of the Navajo Nation Council hereby approves the Diné
20 Uranium Remediation Advisory Commission Rules of Order, attached hereto as
21 **Exhibit B**.

23 **Section Five. Effective Date**

24 The effective date of the Rules of Order and the amendments to the Plan of Operation
25 of the Diné Uranium Remediation Advisory Commission is the date it is certified by
26 the Chairperson or Pro Tem Chairperson of the Naabik'iyáti' Committee of the
27 Navajo Nation Council pursuant to 2 N.N.C. § 189 (A).
