17	Section One. Authority
18	A. The Resources and Development Committee is a standing committee of the Navajo
19	Nation Council. 2 N.N.C. § 500(A).
20	B. The Resources and Development Committee of the Navajo Nation Council has
21	authority to give final approval of all land withdrawals, non-mineral leases,
22	permits, licenses, rights-of-way, surface easements and bonding requirements on
23	Navajo Nation lands and unrestricted (fee) land. This authority shall include
24	subleases, modifications, assignments, leasehold encumbrances, transfers,
25	renewals, and terminations. 2 N.N.C. § 501 (B)(2).
26	Section Two. Findings
27	A. Tuba City Regional Health Care Corporation has submitted a request for a lease
28	to occupy 39.69 acres, more or less, on Navajo Nation Trust Lands in Tuba City,
29	Arizona. The proposed Lease is attached hereto as Exhibit 1.

- B. The proposed Lease of Tuba City Regional Health Care Corporation of 39.69 acres, more or less, is described in **Exhibit 2.**
- C. Environmental, archaeological studies and clearances, and Consent Form to Use Navajo Nation Lands have been completed and are attached hereto and incorporated herein by this reference. The Biological Resources Survey is attached hereto as Exhibit 3. The Cultural Resources Survey is attached hereto as Exhibit 4. The Navajo Nation Environmental Protection Agency memorandum is attached hereto as Exhibit 5. The Environmental Assessment is attached hereto as Exhibit 6. The Consent to Use Navajo Nation Lands is attached as Exhibit 7.
- D. The Resolution of the Tuba City Regional Health Care Corporation Board of Directors requests a surface use lease from the Navajo Nation for a Long-Term Care, Cancer, and Rehabilitation Facility. Resolution RCRHCC 07-08-22 is attached as Exhibit 8.
- E. The To'nanees'dizi Local Government supports a surface lease from the Navajo Nation to the Tuba City Regional Health Care Corporation for a Long-Term Care, Cancer, and Rehabilitation Facility. Resolution TND-08-01-2-22 is attached as **Exhibit 9**.
- F. The Executive Official Review Document No. 020543 is attached hereto as Exhibit 10.

Section Three. Approval:

- A. The Resources and Development Committee of the Navajo Nation Council hereby approves a Lease for the Tuba City Regional Health Care Corporation, for 39.69 acres, more or less, of Navajo Nation Trust Lands in the Tuba City Chapter vicinity, Navajo Nation (Coconino County, Arizona). The Navajo Nation hereby approves the Lease subject to, but not limited to the Terms and Conditions in the Lease attached hereto as **Exhibit 1**.
- B. The location is more particularly described on the survey maps attached as **Exhibit 2**.

C. The Navajo Nation hereby authorizes the President of the Navajo Nation to execute any and all documents necessary to implement the intent and purpose of this resolution.
