23	B. The Resources and Development Committee shall review and make recommendations to	
24	the Budget and Finance Committee concerning the budget in accordance with the annual	
25	budget instructions. 12 N.N.C. § 840 (A).	
26	C. The Budget and Finance Committee is a standing committee of the Navajo Nation	
27	Council authorized to make recommendations to the Council on the budgeting and	
. 28	management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The Budget and	
29	Finance Committee is specifically authorized to make recommendations to the Council	
30	regarding the Navajo Nation's annual Comprehensive Budget for each Fiscal Year. 12

- D. The Budget and Finance Committee finds that approval of the proposed FY2025 Budget for the Division of Transportation and inclusion of such Budget in the Navajo Nation's FY2025 Comprehensive Budget is in the best interest of the Navajo Nation.

- H. The Resources and Development Committee hereby authorizes the Chairwoman and the Vice-Chairman to negotiate with the Budget and Finance Committee on these recommendations.
