19	SECTION ONE. AUTHORITY	
20	A. The Resources and Development Committee is a standing committee of the Navajo	
21	Nation Council with oversight authority over the Navajo Nation Division of Economic	
22	Development. 2 N.N.C. § 500(A); 2 N.N.C. § 501 (C)(1).	
23	B. The Resources and Development Committee shall review and make recommendations to	
24	the Budget and Finance Committee concerning the budget in accordance with the annual	
25	budget instructions. 12 N.N.C. § 840 (A).	
26	C. The Budget and Finance Committee is a standing committee of the Navajo Nation	
27	Council authorized to make recommendations to the Council on the budgeting and	
28	management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The Budget and	
29	Finance Committee is specifically authorized to make recommendations to the Council	
30	regarding the Navajo Nation's annual Comprehensive Budget for each Fiscal Year. 12

SECTION TWO. FINDINGS

- A. The Resources and Development Committee and the Budget and Finance Committee held budget meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed FY2025 Budget for the Division of Economic Development. 12 N.N.C. § 840(A).

- C. Pursuant to the Navajo Nation Appropriations Act, Oversight Committee budget recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).
- D. The Budget and Finance Committee finds that approval of the proposed FY2025 Budget for the Division of Economic Development and inclusion of such Budget in the Navajo Nation's FY2025 Comprehensive Budget is in the best interest of the Navajo Nation.

SECTION THREE. RESOURCES AND DEVELOPMENT COMMITTEE RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2025 BUDGET FOR THE DIVISION OF ECONOMIC DEVELOPMENT AND RELATED MATTERS

- A. The Resources and Development Committee hereby recommends the FY2025 Budget for the Division of Economic Development, as detailed in the "Fund Type Budget Summary" attached hereto as Exhibit A, and in the Resources and Development Committee's Report, to be attached as Exhibit G.

- D. The Resources and Development Committee recommends certain Conditions of Appropriation and Legislative Concerns, if any, as listed in **Exhibit D**, and in the Resources and Development Committee's Report to be attached as **Exhibit G**.
- E. The Resources and Development Committee recommends that certain Unmet Needs, if any, for the Division of Economic Development be included in the FY2025 Comprehensive Budget, as explained in Exhibit E. and in the Resources and Development Committee's Report to be attached as Exhibit G.
- F. The Resources and Development Committee has been presented with the External Funds Anticipated in FY2025, if any, as listed in **Exhibit F**.
- G. The Resources and Development Committee recommends that the Budget and Finance Committee approve the Division of Economic Development's FY2025 Budget and all Committee recommendations as set forth in Exhibits A-E and Exhibit G, the Resources and Development Committee, Committee Report.
- H. The Resources and Development Committee hereby authorizes the Chairwoman and the Vice-Chairman to negotiate with the Budget and Finance Committee on these recommendations.
