23	B. The Budget and Finance Committee is a standing committee of the Navajo Nation	
24	Council authorized to make recommendations to the Council on the budgeting and	
25	management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The Budget and	
26	Finance Committee is specifically authorized to make recommendations to the Council	
27	regarding the Navajo Nation's annual Comprehensive Budget for each Fiscal Year. 12

30	SECTION TWO. FINDINGS

- C. Per the Navajo Nation Appropriations Act, Oversight Committee budget recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).
- D. The Budget and Finance Committee finds that approval of the proposed FY2025 Budget for the Division of Social Services and inclusion of such Budget in the Navajo Nation's FY2025 Comprehensive Budget is in the best interest of the Navajo Nation.

# SECTION THREE. HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2025 BUDGET FOR THE DIVISION OF SOCIAL SERVICES AND RELATED MATTERS

A. - G. - H. The Health, Education and Human Services Committee hereby authorizes the Chairwoman and the Vice-Chairman to negotiate with the Budget and Finance Committee on these recommendations.
