25	and management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The BFC is	
. 26	specifically authorized to make recommendations to the Council regarding the Navajo	
27	Nation's annual Comprehensive Budget for each Fiscal Year. 12 N.N.C. § 840(A).
