BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Office of the Controller. 2 N.N.C. §300(A); 12 N.N.C. §301(B)(13).

B. Each Oversight Committee, including the Budget and Finance Committee, shall review and make recommendations regarding the programs under its oversight responsibility, regarding the Navajo Nation’s Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

C. The Office of the Controller (“OOC”) is under the oversight authority of the Budget and Finance Committee. 2 N.N.C. §301(B)(13)

SECTION TWO. FINDINGS

A. The Budget and Finance Committee held a meeting regarding the FY2025 Budget.

B. During this meeting, the Budget and Finance Committee reviewed and considered the

1 for the 25 Programs listed in **Exhibit A**.

3 **SECTION THREE. RECOMMENDING THE PROPOSED FISCAL YEAR 2025**
4 **BUDGET FOR FIXED COSTS FOR 25 NAVAJO NATION**
5 **PROGRAMS**

6 A. The Budget and Finance Committee hereby accepts and recommends, with the changes
7 described herein (if any), the proposed Navajo Nation Fiscal Year 2025 Budget for Fixed
8 Costs for the 25 Navajo Nation Programs and accounts listed in the **Exhibit A** “Fund Type
9 Budget Summary” attached hereto.

10 B. The Budget and Finance Committee recommends the changes to the proposed Fixed Costs
11 Budgets shown in Exhibit A, which changes are listed in the **Exhibit B** “General Fund
12 Comparative Summary” attached hereto.

13 C. The Budget and Finance Committee recommends the changes to the General Fund Budget,
14 as shown in the **Exhibit C** “Recommended Changes to the General Fund Budget” attached
15 hereto.

16 D. The Budget and Finance Committee recommends approval of the Conditions of
17 Appropriation and Legislative Concerns listed in the **Exhibit D** “Recommended Conditions
18 of Appropriation and Legislative Concerns” attached hereto.

19 E. The Budget and Finance Committee recommends approval of the Unmet Needs listed in the
20 **Exhibit E** attached hereto.

21 F. The Budget and Finance Committee recommends to the Navajo Nation Council that all such
22 changes and Committee recommendations described herein be incorporated into the Navajo
23 Nation’s FY2025 Comprehensive Budget.

25 **SECTION FOUR. EFFECTIVE DATE**

26 This Act shall become effective as provided in 2 N.N.C. §189(A) and 2 N.N.C. §221(C).

28 **SECTION FIVE. SAVING CLAUSE**

29 If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by
30 a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the

1 remainder of this Action shall be the law of the Navajo Nation.
