- B. During this meeting, the Budget and Finance Committee reviewed and considered the proposed FY2025 budget for OMB, after receiving public comment on OMB's proposed budget, a presentation by OMB staff, and Committee deliberations.
- C. The Budget and Finance Committee finds that approval of OMB's proposed FY2025 budget, with the changes recommended herein (if any), is in the best interest of the Navajo Nation.

SECTION THREE. APPROVING AND RECOMMENDING THE FISCAL YEAR 2025 BUDGET FOR THE OFFICE OF MANAGEMENT AND BUDGET

- A. The Budget and Finance Committee hereby approves the FY2025 budget for OMB, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**, with the changes (if any) shown below.
- B. The Budget and Finance Committee hereby approves certain revisions to the FY2025 budget amount for OMB, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**.
- C. The Budget and Finance Committee hereby recommends to the Navajo Nation Council certain changes to the General Fund Budget, as described in the "Recommended Changes to the General Fund Budget" attached hereto as **Exhibit C**.
- D. The Budget and Finance Committee hereby recommends to the Navajo Nation Council certain Conditions of Appropriation and Legislative Concerns, as listed in the **Exhibit D** attached hereto.
- E. The Budget and Finance Committee hereby recommends to the Navajo Nation Council that certain Unmet Needs for OMB be included in the FY2025 Comprehensive Budget, as explained in the Exhibit E attached hereto.
- F. The Budget and Finance Committee hereby recommends that the Navajo Nation Council approve the FY2025 budget for the Office of Management and Budget, as well as all Budget and Finance Committee recommendations shown in the attached **Exhibits B-E**, and that such recommendations be incorporated into the Navajo Nation's FY2025 Comprehensive Budget.
