

**RELATING TO THE BUDGET AND FINANCE COMMITTEE;
APPROVING AND RECOMMENDING THE FISCAL YEAR 2025
BUDGET FOR THE OFFICE OF THE AUDITOR GENERAL**

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Office of the Auditor General. 2 N.N.C. §300(A) and (C).
- B. Each Oversight Committee, including the Budget and Finance Committee, shall review and make recommendations regarding the programs under its oversight responsibility, regarding the Navajo Nation’s Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

SECTION TWO. FINDINGS

- A. The Budget and Finance Committee held a meeting regarding the FY2025 Budget for the Office of the Auditor General.
- B. During this meeting, the Budget and Finance Committee reviewed and considered the proposed FY2025 budget for OAG.
- C. The Budget and Finance Committee approves the proposed FY2025 budget as indicated in

1 the Exhibits outlined in Section Three, below.

3 **SECTION THREE. APPROVING AND RECOMMENDING THE FISCAL YEAR 2025**
4 **BUDGET FOR THE OFFICE OF THE AUDITOR GENERAL**

5 A. The Budget and Finance Committee hereby approves the FY2025 Budget for the OAG, as
6 detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**, with the changes
7 (if any) shown below.

8 B. The Budget and Finance Committee hereby approves certain revisions to the FY2025 budget
9 amount for OAG, as shown in Columns D and E in the "General Fund Comparative
10 Summary" attached hereto as **Exhibit B**.

11 C. The Budget and Finance Committee hereby recommends to the Navajo Nation Council
12 certain changes to the General Fund Budget, as described in the "Recommended Changes to
13 the General Fund Budget" attached hereto as **Exhibit C**.

14 D. The Budget and Finance Committee hereby recommends to the Navajo Nation Council
15 certain Conditions of Appropriation and Legislative Concerns, as listed in the **Exhibit D**
16 attached hereto.

17 E. The Budget and Finance Committee hereby recommends to the Navajo Nation Council that
18 certain Unmet Needs for OAG be included in the FY2025 Comprehensive Budget, as
19 explained in the **Exhibit E** attached hereto.

20 F. The Budget and Finance Committee hereby recommends that the Navajo Nation Council
21 approve the FY2025 Budget for OAG, as well as all Budget and Finance Committee
22 recommendations shown in the attached **Exhibits B-E.**, and that such recommendations be
23 incorporated into the FY2025 Comprehensive Budget.

25 **SECTION FOUR. EFFECTIVE DATE**

26 This Act shall become effective as provided in 2 N.N.C. §189(A) and 2 N.N.C. §221(C).

28 **SECTION FIVE. SAVING CLAUSE**

29 If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by
30 a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the

remainder of this Act shall be the law of the Navajo Nation.
