2	SECTION FIVE. SAVING CLAUSE
3	If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by
4	a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the
5	remainder of this Act shall be the law of the Navajo Nation.
