## LEGISLATIVE SUMMARY SHEET

TITLE OF RESOLUTION: AN ACTION RELATING TO RESOURCES AND DEVELOPMENT COMMITTEE; APPOINTING DONOVAN HANLEY TO THE MANAGEMENT BOARD OF THE NAVAJO NATION HOSPITALITY ENTERPRISE

PURPOSE: The purpose of this legislation is to appoint Mr. Donovan Hanley to the Navajo Nation Hospitality Enterprise's Management Board for a term of three (3) years.

Final Authority: Resources and Development Committee

Vote Required: Simple Majority

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each Council Delegate to review the proposed resolution in detail.

- V(A) of the Plan of Operation states that "[t]he Management Board shall consist of five (5) members appointed for staggered three-year terms by the President of the Navajo Nation with the concurrence of the Economic Development Committee [now, the Resources and Development Committee] of the Navajo Nation Council.
- B. Article V(B) of the Plan of Operation states that "Of the five (5) Board members appointed, one (1) member must be an experienced business person, one (1) member from the Government Services Committee [now the Naabik'íyáti Committee] of the Navajo Nation Council; one (1) from the Economic Development Committee [now the Resources and Development Committee] of the Navajo Nation Council; and two (2) members must have recognized expertise and substantial management experience in the motel-restaurant industry. No other employee of the federal or Navajo Nation government shall be a member of the Management Board. No Board member shall be an employee of the Enterprise."
- C. Each NNHE Board member shall serve a term of three (3) years. Plan of Operation Article V(A).
- D. Between 30 and 60 days prior to the expiration of any Board member's term, the President of the Navajo Nation is to appoint a qualified person to fill the expected Board member vacancy. Plan of Operation Article V(C).
- E. If the President of the Navajo Nation fails to nominate a qualified individual to fill the vacant Board position within 60 days, the Resources and Development Committee may nominate and confirm an appointment to the NNHE Management Board on its own initiative. Plan of Operation Article V(H).
- F. NNHE advertised a vacant Management Board position and Mr. Donovan Hanley submitted a letter of interest to NNHE along with his resume, which are attached as **Exhibit A**.
- G. On November 21, 2023, the NNHE Management Board passed Resolution No. 2023-6 supporting the appointment of Donovan Hanley to the NNHE Management Board to serve in the capacity as an "Industry Expert" on the Board. On January 16, 2024,

NNHE Chief Executive Officer Stan Sapp sent a letter to President Dr. Buu Nygren submitting NNHE Resolution No 2023-6 and Mr. Hanley's letter of interest and resume to President Nygren for consideration. NNHE Resolution No. 2023-6 and the January 16, 2024 letter are herein attached as **Exhibit B**.

- H. President Nygren did not nominate a qualified individual to fill the vacant Board position within 60 days after being notified of the vacancy.
- I. Resources and Development Committee therefore finds it in the best interest of the Navajo Nation to appoint Donovan Hanley to the NNHE Management Board to serve as an "Industry Expert".

## SECTION THREE. APPROVAL

The Resources and Development Committee of the Navajo Nation Council hereby confirms the appointment of Donovan Hanley to the Navajo Nation Hospitality Enterprise's Management Board for a term of three (3) years.
