- B. The Commission consists of seven (7) Commissioners appointed by the President of the Navajo Nation and confirmed by the appropriate committee of the Navajo Nation Council. 2 N.N.C. § 3454(A).
- C. An appointment to the Commission shall be for a period of four (4) years. 2 N.N.C. § 3454(B).
- D. The President of the Navajo Nation has appointed Darrah Blackwater to the Navajo Telecommunications Regulatory Commission. The appointment letter is attached as **Exhibit A**, Ms. Blackwater's letter of interest is attached as **Exhibit B** and Ms. Blackwater's resume is attached as **Exhibit C**.
- E. The Navajo Nation finds it in the best interest of the Navajo Nation to confirm the appointment of Ms. Darrah Blackwater to the Navajo Telecommunications Regulatory Commission for a period beginning October 1, 2024, and ending September 30, 2028.

## SECTION THREE. CONFIRMATION

The Naabik'íyáti Committee of the Navajo Nation Council, on the recommendation of Resources and Development Committee, hereby confirms the appointment of Darrah Blackwater to the Navajo Telecommunications Regulatory Commission for a term beginning October 1, 2024, and ending September 30, 2028.
