PURPOSE: The purpose of the resolution is to approve the SW DinehNet, LLC Telecommunication Tower Site Lease within the Coyote Canyon Chapter community, and approve reduction of the \$12,000 annual telecommunication tower site lease fee to \$6,000 annual fee.

19	Section One. Authority	
20	A. The Resources and Development Committee of the Navajo Nation Council has	
21	authority to give final approval for "[a]ll land withdrawals, non-mineral leases,	
22	permits, licenses, rights-of-way, surface easements and bonding requirements on	
23	Navajo Nation lands and unrestricted (fee) lands. This authority shall include	
24	subleases, modifications, assignments, leasehold encumbrances, transfers, renewals,	
25	and terminations. 2 N.N.C. § 501(B)(2).

27	Section Two. Findings	
28	A. SW DinehNet, LLC is requesting a Telecommunication Tower Site Lease within the	
29	Coyote Canyon Chapter community. SW DinehNet, LLC proposed Brimhall	
30	Telecommunication Tower Site Lease is attached hereto as Exhibit A .	

- B. The proposed SW DinehNet, LLC Brimhall Telecommunication Tower Site Lease site is described in **Exhibit B**.
- C. Environmental and archaeological studies and clearances have been completed and are attached hereto and incorporated herein by this reference. The Biological Resources Compliance Form is attached hereto as **Exhibit C**. The Navajo Nation Department of Fish and Wildlife letter dated August 18, 2023 is attached hereto as **Exhibit D**. The Heritage & Historic Preservation Department Cultural Resource Compliance Form is attached hereto as **Exhibit E**.
- D. The Field Clearance Checklist of land users is attached hereto as **Exhibit F**.
- E. The Coyote Canyon Chapter resolution "... SUPPORTING A FIBER OPTIC BROADBAND BUILDOUT AND ESTABLISHMENT OF BRANCH LIBRARIES AT THE CHAPTER TO BE FUNDED BY FCC E-RATE FUNDING AND OTHER FUNDING SOURCES" is attached hereto as **Exhibit G**.
- F. A letter from SW DinehNet to the Division of Natural Resources dated October 26, 2023 describing the Telecommunication Tower Site Lease project is attached as Exhibit H.
- G. The Executive Official Review Document No. 022434 is attached as Exhibit I.
- H. The annual consideration, or fee, for a telecommunication tower lease is \$12,000 per year. RCAP-25-07 (amended certain exhibits in RCJY-98-06 which approved the delegation of authority to the Director of the Land Department to approve telecommunication leases).
- I. SW DinehNet, LLC says "[t]he cost to construct the towers has increased considerably due to, i.e., supply and demand, terrain, physical location of structure, requirements for power and back-haul, obtaining land-owner consents, etc. Further, the costs to maintain the towers will exceed the anticipated customers we expect to serve." See, Exhibit H.
- J. SW DinehNet, LLC has requested a reduction of the annual rental rate of \$12,000 to an annual rental rate of \$6,000 for the Telecommunication Tower Site Lease. See, Exhibit H.

Section Three. Approval of Telecommunication Tower Site Lease

The Resources and Development Committee of the Navajo Nation Council hereby approves the SW DinehNet, LLC Telecommunication Tower Site Lease within the Coyote Canyon Chapter community, subject to, but not limited to the Terms and Conditions attached hereto as **Exhibit A**. The location is more particularly described on the survey maps attached as **Exhibit B**.

Section Four. Approval of a Reduction of the Annual Rental Rate

The Resources and Development Committee of the Navajo Nation Council hereby approves reduction of the \$12,000 annual telecommunication tower site lease fee to \$6,000 annual fee for the SW DinehNet, LLC for the Telecommunication Tower Site Lease within the Coyote Canyon Chapter community.
