SECTION ONE. AUTHORITY

A. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700 (A).

B. The Speaker of the Navajo Nation Council appoints and the Naabik'íyáti' Committee confirms the Commissioners to the Emergency Management Commission. 2 N.N.C. 882(B); CO-45-12, Section Five, References to Previous Standing Committees.

SECTION TWO. FINDINGS

A. The Navajo Nation Council established the Emergency Management Commission within the Legislative Branch. 2 N.N.C. § 881.

B. The Emergency Management Commission's purpose is to "coordinate emergency and disaster relief services by the Navajo Nation and non-tribal entities" together with the Navajo Department of Emergency Management. 2 N.N.C. § 883(A).

C. The Speaker shall appoint six individuals with technical expertise in each of these areas: civil defense/law enforcement, first aid/health, firefighting, environmental, broadcast and print media, and an elected official. 2 N.N.C. §882(A).

1 D. The Speaker appointed the following individuals, whose letters of interest and resumes
