18	SECTION ONE. AUTHORITY	
19	A. The Resources and Development Committee is established as a standing committee	
20	of the Navajo Nation Council. 2 N.N.C. § 500(A).	
21	B. Pursuant to 2 N.N.C. §501(B)(2), the Resources and Development Committee of the	
22	Navajo Nation Council has authority to give final approval of all land withdrawals,	
23	non-mineral leases, permits, licenses, rights-of-way, surface easements and bonding	
24	requirements on Navajo Nation lands and unrestricted (fee) land. This authority shall	
25	include subleases, modifications, assignments, leasehold encumbrances, transfers,	
26	renewals, and terminations.	
27	SECTION TWO. FINDINGS	
28	A. The Resources Committee (Predecessor to the Resources and Development) passed	
29	Resolution No. RCJY-142-92 "Establishing a Moratorium on New Structures, New	
30	Homesite and Range Units within the Navajo Commercial Forest Pending	

Development and Approval of a New Forest Management Plan", attached hereto and incorporated herein as **Exhibit A**.

B. A homesite lease application requirements include the Certificate of Navajo Indian Blood, Archaeological Clearance, Cultural Resources Compliance Form, Biological Clearance Form, Consent Form, land survey plat maps. RDCO-74-16, RDCJA-06-24.

- C. Ms. Delila F. Begay has applied for a homesite lease within the Navajo Commercial Forestry Area and within Tsaile/Wheatfields Chapter, Navajo Nation. The Homesite Application Form, Cultural Resources Compliance Form, the Field Clearance Certification, the Consent Forms, a map, a Checklist for Homesite Lease Application, a Homesite Lease Flowchart, an estimate for land survey services, a Request Form for Homesite Biological Clearance Form, and a resolution of the Tsaile/Wheatfields Chapter SUPPORTING DELILA BEGAY REQEUST TO MEET WITH THE RESOURCES AN DEVELOPMENT COMMITTEE REGARDING HOMESITE LEASE REQUEST are attached as **Exhibit B**.
- D. A memorandum from the Program Manager of the Forest Services Program/NFD, attached as **Exhibit C**, states the homesite lease application is within the commercial forest boundary and the Resources and Development Committee is authorized to give final approval authority because of the moratorium described in Resources Committee Resolution RCJY-142-92. The memorandum, **Exhibit C**, does not state what type of forested area the requested homesite will be located in—an area of the forest that has other homesites and is developed or in an area of the forest that is habitat to endangered species, plant life and other such distinctions.

SECTION THREE. WAIVING RESOLUTION NO. RCJY-142-92

A. The Resources and Development Committee of the Navajo Nation Council hereby waives the applicability of Resolution No. RCJY-142-92 "Establishing a Moratorium on New Structures, New Homesite and Range Units within the Navajo Commercial Forest Pending Development and Approval of a New Forest Management Plan" (Exhibit A) with respect to the homesite lease application for Delila F. Begay for a homesite lease application within the Navajo Commercial Forestry Area and within

1	Tsaile/Wheatfields Chapter, Navajo Nation, as further described in the attached
2	Exhibit B, subject to the following terms and conditions:
3	1. The Lessee shall not infringe on the operation and management of the Navajo
4	Commercial forestry authority of the Navajo Nation.
5	2. The Lessee shall comply with provisions for Homesite Lease Policies and
6	Procedures for Tribal Trust/Fee Land.
7	3. The Lessee shall obtain a permit from the Navajo Forestry Department prior
8	to cutting any trees within the homesite lease area.
9	B. The Resources and Development Committee of the Navajo Nation Council hereby
10	authorizes the Director of the Navajo Land Department to process and to execute all
11	documents necessary to effectuate the intent and purpose of this resolution.
